Why did you get this notice?

You are receiving this notice because you are a potential member of a class in the case of *DHS Probationary Employees 1 Class v. Department of Homeland Security*. The case is brought on behalf of all probationary employees at the Department of Homeland Security (DHS) who were terminated by DHS between February 14 and February 20, 2025, who were not terminated based on specific, individual performance or conduct deficiencies. The case, which is pending before the Merit Systems Protection Board (MSPB), challenges the terminations alleging the terminations were an unlawful Reduction in Force (RIF)—a downsizing that DHS executed without affording employees the rights to which they are entitled by law when a RIF is conducted. You received this notice because **DHS has identified you as one of the probationary employees who were terminated during this period who may be a member of the class.**

What is class certification?

Class certification means that a claim challenging your termination can go forward with those of all other probationary employees terminated during the same time period. For all these employees, the judge can collectively adjudicate claims that the terminations were a RIF and DHS violated the law by not following the procedures required for executing RIFs. If you take no action and are determined to be a member of the class, any ruling from the judge will apply to you, and you will not be able to file claims against DHS about the same issues.

Who is in the class?

Document Number: 3433558

The judge has defined the class to include any DHS employees serving a probationary or trial period who were issued termination notices between February 14-20, 2025, as a result of instructions from DHS leadership to terminate those serving a probationary or trial period. The class does *not* include anyone who: (1) was terminated in the same time period based on specific, individual performance or conduct deficiencies; (2) enrolled in DHS's deferred resignation program or entered a similar agreement waiving their rights to pursue an appeal in the MSPB; and (3) any employee who received a substantively identical termination notice in the same time frame but met the definition of "employee" under 5 USC 7511.¹

¹ "Employee" in 5 USC 7511 means someone who is either (1) a competitive service employee with1 year of continuous service under other than a temporary appointment limited to 1 year or less, (2) a preference eligible in the excepted service who has completed 1 year of continuous service in the same or similar positions, or (3) an individual in the excepted service who has completed 2 years of continuous service in the same or similar positions under other than a temporary appointment of 2 years or less or not pending conversion to the competitive service.
